

EMS – Incidents by Month

Description This table contains data describing requests for assistance received by ATCEMS. Incident counts are broken out by location, and priority for City of Austin and Travis County incidents.

Response time performance is measured for all incidents for which ATCEMS personnel are the primary call-taker. Requests for assistance received from other agencies are excluded from these calculations. Like incident counts, response time performance is broken out by location and priority for City of Austin and Travis County. Response time performance is not calculated for responses outside the ATCEMS service area (“Other” areas).

As of 24 September 2014, the following response time performance goals are in effect for ATCEMS:
